

Privacy Policy

Welcome to Emotional Wellness Expo LLC ("we," "our," "us"). Your privacy is important to us, and we are committed to protecting the personal information you share with us. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website https://emotionalwellnessexpo.com/web/inicio/ (the "Site"), and any other services we offer (collectively, the "Services").

By using our Services, you agree to the terms of this Privacy Policy.

Information Gathering

We get a variety of personal information when you use the Services, and it usually falls into two categories: information you give us directly and information we collect automatically.

Details You Provide Directly

Fundamental Details. We will gather information from you when you use the Services, such as through our websites, mobile applications, and/or any contracts you may have signed about the Services. Your first and last names, home address, phone number, and email address are a few examples of this information. Additionally, we might gather billing data, including credit card numbers and other details required to finish in-app or online transactions.

1. Information We Collect

We may collect the following types of information:

a. Personal Information

Information you voluntarily provide to us, such as:

- Name
- Email address
- Phone number
- Mailing address
- Payment information (if purchasing tickets or services)
- Any other information you submit through contact forms or registrations

b. Automatically Collected Information

When you access our Site, we may automatically collect:

- IP address
- Browser type and settings
- Device type
- Pages visited and time spent
- Referring website addresses
- Cookies and similar tracking technologies

2. How We Use Your Information



We may use the information we collect to:

- Register you for events or services
- Communicate with you regarding events, promotions, or news
- Respond to inquiries and customer service requests
- Analyze website usage and improve our content and services
- Ensure the security and integrity of our Site
- Comply with legal obligations

3. Sharing of Information

We do not sell or rent your personal information. We may share your information in the following cases:

- **Service Providers:** We may share data with vendors and partners who help us operate the Site and Services (e.g., payment processors, email service providers).
- **Legal Requirements:** We may disclose information if required to do so by law or in response to valid legal requests.
- **Business Transfers:** In the event of a merger, sale, or reorganization, your information may be part of the transferred assets.

4. Cookies and Tracking Technologies

We use cookies and similar technologies to improve your experience, analyze traffic, and for marketing purposes. You may disable cookies through your browser settings, though some features of the Site may not function properly if you do.

5. Data Retention & Security

We implement reasonable administrative, technical, and physical security measures to protect your personal information. However, no online transmission or storage method is 100% secure.

We keep the data we get about you for as long as is required to fulfill the goals for which we gathered it, as well as to comply with our legal requirements and reasonable business interests.

During the use of the Services, we ask that you refrain from sending us and disclosing any sensitive Personal Information, such as social security numbers, information about your race or ethnic origin, political views, religion or other beliefs, health, biometrics or genetic traits, criminal history, or trade union membership.

6. Your Choices and Rights
